Withdrawal Process

Enrollment at SCS is maintained on a continuous basis through student graduation unless a family notifies the school of their intent to withdraw their student(s). To assist in decision making as it relates to budgeting and hiring for the next school year, families are asked to notify SCS by February 28 of the school year prior if they do not intend to return the following school year. Any notifications outside of this time frame are subject to the following fees and penalties:

After February 28 but prior to July 1	Enrollment fee forfeited
After July 1 but prior to first day of school	Enrollment fee and August tuition forfeited
After first day of school for 1st semester withdrawal	Enrollment fee and 1st semester tuition forfeited
During 1st Semester for 2nd semester withdrawal	Enrollment fee forfeited
During 2nd semester for 2nd semester withdrawal	Enrollment fee and annual tuition forfeited
